NOTICE INVITING e-Auction No. 01 /HA-II/SP, JRM/2025-26

The Superintendent of Police, Jhargram, invites e-auctions for the sale of various condemned articles extracted from different units of the Jhargram Police, through online mode.

The offers should be submitted via the e-Auction process to be conducted on the e-Auction Portal (<https://eauction.gov.in>) of the National Informatics Centre, Government of India, as detailed below. The items shall be sold to the bidder quoting the consolidated highest rate.

Bids are invited for the entire lot (i.e., all items listed in Annexure-I as unserviceable and obsolete) as a whole; no bid will be accepted for any part thereof. 
## Terms & Conditions

1. **Digital signature certificate (DSC):** Intending bidders must have DSC (Digital signature certificate) for submission of their bids online through Government e-Auction system (<https://eauction.gov.in>) to participate in the competitive bidders.
2. **Earnest Money Deposit (EMD):** Bidders must deposit 10% of the total auction value as EMD via Demand Draft/Banker's Cheque from any nationalised bank, in favour of the Superintendent of Police, Jhargram. Failure to deposit EMD will lead to disqualification. No interest will be paid on EMD. If the successful bidder backs out or fails to take delivery, the EMD will be forfeited. EMD of unsuccessful bidders will be refunded after the award of the contract.
3. **Valid Certificates:** Bidders must hold a valid certificate issued by the Ministry of Environment & Forest or the Central/State Pollution Control Board for disposal/handling of e-waste, old batteries, and other hazardous waste items (valid at both the time of bidding and lifting of materials).
4. **Inspection:** Items will be sold on an "As is, where is" basis. Interested bidders may inspect materials on working days between 11:00 AM and 2:00 PM by contacting the Addl. SP (HQ), Jhargram. No inspection requests will be entertained after bid submission.
5. **Disposal Compliance:** Electronic waste must be disposed of in an eco-friendly manner as per Government of India guidelines.
6. **Risk after Payment:** No claims for damage, theft, fire, or any other loss will be entertained after full payment is made.
7. **Lifting Period:** The successful bidder must lift the entire lot at their own cost within 7 (seven) days from the date of issue of the Release Order.
8. **Lifting Time:** Materials must be lifted during office hours (11:00 AM – 3:00 PM).
9. **Payment:** The balance sale value must be paid within 7 (seven) calendar days (including the date of acceptance/sale order).
10. **Damage Liability:** The lifting must be done without causing damage to premises, roads, drains, etc. Any damage must be compensated by the buyer.
11. **No Claims Later:** Any leftover materials not removed during the lifting period cannot be claimed later.
12. **Non-Compliance:** Tenders not complying with the above conditions are liable for rejection.


